### Instructions to Candidates :

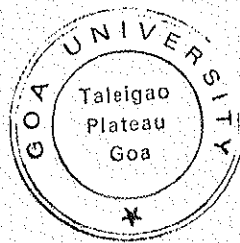
1. Candidates are requested to be present at the place of Examination fifteen minutes before the commencement of the Examination.
