

Guidelines for payments under VVM's Sports Policy (w.e.f. June 2018)

1. Travelling Allowance to be paid to players in case of teams representing the College for Inter-Collegiate tournaments organized by Goa University, State Associations /Federations
 - a) *For teams comprising 1-3 players-* to & fro bus fare at actual (KTC Shuttle bus fare to & from Margao KTC to Panaji, Bambolim, Mapusa, Vasco etc. and concessional fare on other routes). Players should claim TA in the prescribed form duly certified by the College Director of Physical Education & Sports and countersigned by the Principal of the College.
 - b) *For teams comprising 4-6 players or 7-12 players* -each player shall be paid as per a) above even if the team travels by personal 4-wheelers volunteered by students. It shall be the responsibility of the College DPE&S to ensure that the TA so sanctioned is paid to the student/s whose vehicles have been used.
 - c) *For teams comprising more than 12 players-* The TA allowance to individuals will not be paid, however the transport vehicle may be hired, at the cost of the respective institution, from an authorised travel services enterprise, as far as is possible, having GST Registration. In the event the owner of the transport vehicle is not required to have GST Registration or is a composite dealer under the GST law, such a declaration must be stated in owner's bill.
 - d) For any Team Event organised by Goa University or State Association/Federation, the players shall travel as a team irrespective of the date and time of individual events, until such time as all participation is not completed.
2. Practice allowances shall be paid @ Rs 20 (practice within VVM campus) and @Rs. 50 (practice outside VVM campus) per day per student (for minimum two hours practice per day) for Maximum 10 days or more as proposed by the Director of Physical Education & Sports and approved by the Principal of the College. Students shall not be permitted to miss more than the last two lectures per day for maximum 10 days or actual days of practice, which shall be certified by College DPE&S. Details of the practice of each game are to be submitted to the College Principal at least 3 days in advance to enable co-ordination and for

monitoring the attendance of the players. In event of any change required, the Head of the Institution must intimate the concerned DPE&S with a day of submission of the intimation.

3. Kit Allowance / Honorarium to be paid @Rs 250/- per student per game.
4. As per provision in VVM's Sports Policy point 3 – Incentives (B) cash prizes in case of team championship shall be paid as follows.

Where the College team does not win any of the top three positions, but an individual team member wins a Gold, Silver or Bronze medal in individual events (as may happen in the case of Athletics, Weightlifting, Powerlifting, Judo, etc.), the individual medalist shall be awarded a cash prize of Rs 1500, 1000 and 750 respectively.

Note:

- The above provisions are effective from the current academic year 2018-19 for aided programme as well as self-financed programmes.
- The prizes and allowances are to be paid by digital mode to the extent possible.
- Annual allocation of Rs. 5,000/- for Discretionary spending by the Director of Physical Education and Sports of the Institution.

The higher allowances and cash prizes may be paid from the non-salary grant for students from the aided programmes, as may be permissible under the applicable rules.

The Bills for the above claims are to be submitted by DPE&S duly certified to the Principal for payments within seven working days from the date of end of the game/event. In case the approval for the bills is not granted by the Principal within seven working days, the same shall be referred to the Chairman GC whose decision shall be final.
