CIRCULAR

Sub: Extension of Aadhaar Service free of cost through 'myAadhaar' portal for Document Update

In the interest of the residents, UIDAI has amended the Aadhaar (Enrolment and Update) Regulations, 2022 vide Notification dated 09/11/2022 as under:

"Aadhaar number Holders may, on completion of every 10 years from the date of Enrolment for Aadhaar, update their supporting documents in Aadhaar, at least once, by submitting Proof of Identity (POI) and Proof of Address (POA) documents".

Keeping One's Aadhaar updated helps in ease of living, better service delivery, enables accurate authentication and continued accuracy of information in the Aadhaar database. The Aadhaar Update service can be availed at any Aadhaar Centre on payment of a nominal fee of Rs.50/- approved by the UIDAI, New Delhi.

However, in order to encourage the residents to update their documents (Proof of Identity & Proof of Address) in Aadhaar, UIDAI had provided Aadhaar Update Service free of cost to those residents who are updating their document through 'myAadhaar' portal (which

can be downloaded on the mobile phone) for a period of 03 months w.e.f. 15/03/2023 to 14/06/2023.

Based on the positive response from the residents and the recommendations received from the UIDAI Regional Offices, the Ministry of Electronics and Information Technology, New Delhi has decided to extend the facility of updating documents through 'myAadhaar' portal free of cost for a further period of 03 months with effect from 15/06/2023 to 14/09/2023. The facility is available on "myAadhaar" portal at <https://myaadhaar.uidai.gov.in/>.

All the Heads of Departments are hereby requested to bring the contents of this Circular to the notice of the employees under your charge including Sub Offices if any, to avail the advantage of this facility. It is also requested to display the Circular on the Notice Boards of your Office for public viewing and for their knowledge.


The UIDAI vide Notification dated 09/11/2022 cited above has amended the Aadhaar (Enrolment and Update) Regulations, 2016 (No.2 of 2016) of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 as under:

---16A. Update of Documents.—Aadhaar number holders may, on completion of every 10 years from the date of enrolment for Aadhaar, update their Supporting documents in Aadhaar, at least once, by submitting Proof of Identity (POI) and Proof of Address (POA) documents as specified under Aadhaar Enrolment and Update Regulation 10 hereinabove, so as to ensure continued accuracy of their information in the Central Identities Data Repository (CIDR), in such manner as may be specified by the Authority from time to time.

The above Notification is published in the Gazette of India (Extraordinary) part III- Sec4 dated 09/11/2022 (copy enclosed).

In view of the above, you are kindly requested to bring the contents of this Notification to the notice of all the Aadhaar operators/supervisors of your offices/sub offices for their knowledge and information. It is also requested to display the same on the Notice Boards of your departments/Aadhaar Centre for public information.

भाग-I

प्रारंभिक

1. संक्षिप्त नाम और प्रारंभ - (1) इन विनियमों को आधार (नामांकन एवं अद्यतन) (दसवां संशोधन) विनियम, 2022 (2022 का संख्यांक 6) कहा जाएगा।

(1) ये विनियम इस अधिसूचना के प्रकाशन की तिथि से प्रवृत्त होंगे।

भाग-II

2. विनियम 16 का संशोधन - मूल विनियम के विनियम 16 में, "इस अध्याय में विनिर्दिष्ट अद्यतन प्रक्रिया के अनुसार" शब्दों के स्थान पर "समय-समय पर प्राधिकरण द्वारा विनिर्दिष्ट अद्यतन प्रक्रिया के अनुसार" शब्द प्रतिस्थापित किए जाएंगे।

3. नए विनियम 16क अंतर्वेशन - मूल विनियम के विनियम 16 के बाद, निम्नलिखित नये विनियम को अंतःस्थापित किया जाएगा, नामतः:-

"16क. दस्तावेजों का अद्यतन - आधार नंबर धारक, आधार के लिए नामांकन की तारीख से प्रत्येक 10 वर्ष के पूरा होने पर, उपर्युक्त आधार नामांकन एवं अद्यतन विनियम 10 के अंतर्गत यथा विनिर्दिष्ट पहचान के प्रमाण (पीओआई) और पते के प्रमाण (पीओए) को जमा करने के द्वारा, न्यूनतम एक बार, आधार में अपने सहायक दस्तावेजों को अद्यतित कर सकते हैं, ताकि केंद्रीय पहचान डेटा रिपोजिटरी (सीआईडीआर) में सुरक्षित उनकी जानकारी की अनवरत सटीकता इस प्रकार सुनिश्चित की जा सके, जैसा कि उसे समय-समय पर प्राधिकरण द्वारा विनिर्दिष्ट किया गया हो।"

AADHAAR (ENROLMENT AND UPDATE) (TENTH AMENDMENT)

REGULATIONS, 2022

(No. 6 of 2022)

No. HQ-16027/1/2022-EU-I- HQ (No. 6 of 2022).—In exercise of the powers conferred by sub-clause (a) of sub-section (2) of Section 54 read with Section 23(2)(a) of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act 2016(18 of 2016) the Unique Identification Authority of India, hereby makes the following regulations to further amend the Aadhaar (Enrolment and Update) Regulations, 2016 (No.2 of 2016), namely:-

Part I**PRELIMINARY**

1. **Short title and commencement.**— (1) These regulations may be called the Aadhaar (Enrolment and Update) (Tenth Amendment) Regulations, 2022 (No. 6 of 2022).

(2) These regulations shall come into force with effect from the date of publication of this notification.

Part II

2. **Amendment of Regulation 16.** – In Regulation 16 of the principal Regulation, for the words “in accordance with update procedure specified in this Chapter”, the words “in accordance with update procedure as specified by the Authority from time to time” shall be substituted.

3. **Insertion of new Regulation 16A.** – After Regulation 16 of the principal Regulation, the following new Regulation shall be inserted, namely:-

“16A. **Update of Documents.** – Aadhaar number holders may, on completion of every 10 years from the date of enrolment for Aadhaar, update their supporting documents in Aadhaar, at least once, by submitting Proof of Identity (POI) and Proof of Address (POA) documents as specified under Aadhaar Enrolment and Update Regulation 10 hereinabove, so as to ensure continued accuracy of their information in the Central Identities Data Repository (CIDR), in such manner as may be specified by the Authority from time to time.”

In the interest of the residents, UIDAI amended the Aadhaar (Enrolment and Update) (Tenth Amendment) Regulations 2022 issued vide Notification under Ref.1, to encourage the residents to keep their documents updated in Aadhaar. This helps in ease of living, better service delivery, enables accurate authentication and continued accuracy of information in the Aadhaar database.

2. As per OM dated 18.10.2022, the service to update the document through myAadhaar portal (SSUP) is chargeable @Rs. 25/-.

3. Now, to encourage more residents to update their documents in Aadhaar, it is **decided to provide the service free of cost to the residents through myAadhaar (SSUP) Portal for a period of 03 months starting from 15.03.2023 to 14.06.2023.** Accordingly, the facility for document update shall be available free of cost through myAadhaar (SSUP) portal at <https://myaadhaar.uidai.gov.in/>.
