Orientation on 'Using Lab Resources'

13th July 2019

The PG Department of VVM's Shree Damodar College organized an orientation on 'Using Lab Resources ' on 13/7/2019 for the students of M.Com Part I & II in the M.Com Lab from 11:30 a.m. to 12:15 p.m. The orientation was conducted in two separate sessions for M.Com Part I & II students. The Resource Person for the Orientation was Ms. Venisa D'Costa.

The Orientation was delivered via hands-on experience by the Resource person. The Resource person instructed students on how to use the 'Linux Mint' software that is installed in the M.Com Lab. She also showed the students practically how to save documents, create folders and download images in Linux

Mint. Later she briefed students as to how documents could and should be saved in Microsoft 97 and Microsoft 2007 formats so that students would be able to save their work in college and work on the same at their homes. The Instructor also asked a few students to practically demonstrate whatever she had discussed during the orientation. The orientation was found to be beneficial for students, as many of them were unable to use the Lab since they were not acquainted with Linux Mint Software. The Resource person also assured them that incase of any difficulty they could approach her during College hours. The session concluded at 12:15 p.m.

Talk on Careers in Indian Civil Services

The Career and Placement Cell organised a talk on Careers in Indian Civil services on July 17, 2019. The resource person was Mr. Amit, Udgam IAS Coaching Centre. The talk was aimed at creating awareness amongst students about the various Public sector competitive examinations.

The speaker made a presentation on the various exams under Union Public Service Commission including, IAS, IPS, IFS, IRS, CAPF, CDS, other exams such as Indian Economic Services, RBI, Sports Authority of India-Officer Grade exams and Goa Public Service Commission exams.

Mr. Amit made the students aware of the structure of these exams and the question paper pattern. He also emphasized the need for focused, regular and smart study. He made recommendations for reference and study material to the students. The speaker shared the passing statistics and the opportunities available to students. Assistant Professor Gajanan B. Haldankar along with six students participated in a state level workshop on 'Financial Literacy and Investor Education' on 19th July 2019 held at Dnyanprassarak Mandal's College and Research Center, Assagao.

The resource person for this workshop was Mr. Aman Singh Chawala, a financial advisor based in Mumbai. Mr. Chawala spoke about various investment opportunities and the basic mindset of an individual who finds the need of financial literacy in his/her life. The main concept revolved around not just having information about finance, but to have knowledge in order to implement it in one's daily routine. Mr. Chawala also highlighted the various milestones in the history of the Indian economy such as, LPG (Liberalisation, Privatisation, and Globalisation), Introduction of the Securities and Exchange Board of India (SEBI), technological advancements in share markets etc.

Everybody aspires to become rich someday, or own a luxury car. However, our main goal should be to retire rich, a time where you stop working and money starts working for you! And this is possible when we give topmost priority to our needs instead of our goals and aspirations.

The workshop came to an end at around 4 p.m. with Mr. Chawala giving a live demonstration of two applications called 'Financial Calculator' and 'Buycano' wherein you could calculate your projected interest on investments, information regarding any investment related scheme, and answering online quizzes to prepare for competitive examinations. During Mr. Virkar's session, he elaborated upon and explained the following:



• The need for TDD approach of programming in the curriculum.

• Coding conventions and standards: He explained the general coding conventions and guidelines and stressed that students should be taught these standards right from beginning. He specifically mentioned the conventions and standards of laravel framework, java, PHP and html.

• Design Patterns: He explained the concepts and use of factory patterns, factory functions, singleton, abstract class, interface class, hook functions, empty functions, getters and setters.

• Documentation Standards: The documentation standards and their significance were explained with respect to phpdoc and javadoc. He mentioned that students should be encouraged to document their code right from beginning.

- Database naming standards: He explained how to name the database, tables, and columns. He suggested the use of soft delete instead of hard delete, to use archive, to always include time created, updated, and deleted column, and to use enumeration in database design.
- Code optimization: He recommended using the concepts of indexing, reusability, minimization, exceptions or hooks, normalization, naming spacing, application as service and modularity for code optimization.
- Repositories: He explained the use of repositories (centralized as well as decentralized), versioning system with special mention to Github and semver, 3 levels of versioning (Major, Minor and Patch)
- He suggested using Linux system (debian, archlinux, server centOS) for teaching.
- With regards to development methodologies, he explained about development and production environment.

Mr. Virkar also advised the faculty members to increase their typing speed without looking at the keyboard and to consider learning and teaching the concepts of Angular, Vue, and electron JS.

The session concluded at 3.30 pm. The participants thanked Mr. Virkar and his team for providing them the opportunity to learn and understand the concepts in his organization. The session was a great learning experience for all faculty members, who have expressed the desire to participate in similar sessions in the future.

The BCA/B.Voc Programme Mentoring Council of Shree Damodar College organized a session on Virtualization and Cloud Computing for all teachers of IT/Computer Science of all VVM institutions and interested TY BCA students on 20th August 2019 from 11.30 a.m. to 1.00 p.m. The objective of the Session was to give faculty members an understanding of the basic concepts, tools, and technologies of Virtualization and Cloud Computing Infrastructure.

Chairperson of the Council, Ms. Ekta Agarwal introduced the resource person Mr. Rajeev Vasudevan, who is Director, IT-Infrastructure of a leading MNC. She informed the audience about the objectives of the session and mentioned the need of cloud environment.

Mr. Rajeev Vasudeven initiated the session by explaining the basic, yet complex terminologies of virtualization and cloud computing in layman terms. He gave the basic insight of Virtualization and Cloud computing including security, networking, storage and other infrastructure requirements. He mentioned about Vmware along with its architecture and Cloud space by Amazon and Azure. The concept of SaaS, PaaS, IaaS models of architecture were explained for cloud infrastructure implantation.

He suggested that teachers obtain certifications like CCNA, AWS, Azure, etc... to enable them to keep pace with changing technology. He also mentioned that basic infrastructure, like network backbone, dual internet line from different service provider for 24X7 connectivity, etc.., should be in place before moving on to the cloud environment. He stressed the importance of training the system administrators and staff as per the requirements of technology.

He expressed his willingness to help in a) setting up the cloud infrastructure for the institution, b) designing and reviewing course curriculum in all possible ways and c) guiding students

The resource person for the session was Mr. D.S. Prashant, CEO, Forum for Innovation Incubation Research and Entrepreneurship (FIIRE). He began the session by discussing the challenges that jobseekers face, viz. unemployment, underemployment and unsatisfactory



employment. He stressed that the product remaining the same, technology becomes the differentiator.

Technology has changed the nature of entrepreneurship. E.g. Ola, Airbnb, Swiggy and e-chai. Starting a business is, in a sense, much easier than it was in earlier days, because of the power of technology.

Starting a business involves identifying one's skills and resources, identifying problems and finding solutions and identifying solutions or ideas that are better, cheaper and faster and validate the ideas on this basis.

Mr. Prashant explained about the Business Model Canvas which is a concise version of the more elaborate Business Plan. A Business Model describes the rationale of how an organization creates, delivers and captures value. The model considers the following nine elements:

- 1. Identify customer segments you are serving
- 2. Create value propositions to satisfy customer needs
- 3. Decide about the channels value propositions are delivered to customers through communication, distribution and sales channels
- 4. Develop customer relationships customer relationships are established and maintained
- 5. Revenue streams -results from value proposition successfully offered to customers
- 6. Key resources the assets required to deliver value propositions
- 7. Key activities what activities you need to perform well in your business model.
- 8. Key partners some activities are outsourced and resources are required from outside the business.
- 9. Cost structure the entrepreneur should always multiply the expected expenses by 2 and divide the expected profits by 2.

An entrepreneur has three choices after starting his business: Persevere, Pivot i.e. change direction, or Quit

Mr. Prashant offered the following tips for startups:

- 1. Ask why not
- 2. Bring data not opinions
- 3. There is nothing called over-communication
- 4. Hire for the company not for a job
- 5. Think money last and users first
- 6. Handle yourself well.

20 M.Com Part-I students attended the session, which ended with the vote of thanks by student, Ms. Priyanka Rawat.

During the Session, the resource person gave insights on the type of skill sets and qualities required for a journalist. The guest speaker was accompanied by a lady journalist, who briefed students on the role of women and spoke about females opting for careers in journalism. Awareness About Snake Species

The First Year students of Environmental Studies are learning about biological diversity of different species. As part of the syllabus, a Session on 'Awareness about Snake Species' was organized by Amrut S. Singh for First Year BCA & B.Voc students on 23rdAugust 2019 at 1:00pm. Snakes play a very critical role in maintaining a healthy ecosystem and environment, but due to lack of knowledge and understanding, they are still feared by most people. Around 12 percent of assessed snake species are threatened and their population has declined according to IUCN Red list threatened Species. The main aim of this session was to make the student community aware about different snake species and their conservation. The objectives of this session were to identify and differentiate between non venomous, mildly venomous and venomous species of snakes, to learn the aspects of snake biology (smell and touch) and behavior including how they respond to threat, to know the different techniques for snake handling and rescue and to analyze their importance in the ecosystem.

Mr. Bhiku Bhave, Asst. Professor, Dept. of Computer Science, introduced the resource person to the audience. The session was attended by the students, teaching, and non-teaching staff of the College. Interested students from other programmes also attended the session.

The resource person had brought twelve different snake species. First, he explained and showed students all non-venomous snakes such as Rat Snake, Whitaker's Boa, Checkered Keelback, Bronze back tree snake, Indian Rock Python, Montane Trinket Snake and Common Wolf Snake. Later, he showed mildly venomous snakes such as Forsten Cat Snake and Common Vine Snake. Lastly he showed the venomous snakes such as Common Krait, Russell's viper and Spectacled Cobra. While showing all these species of snakes, he guided the students how to identify the snakes and differentiate among different snake species. He also explained the food patterns of these species. He ably demonstrated different techniques of snake handling and allowed the students to handle non-venomous snakes under his guidance.

The resource person made students aware about different unfounded rumors regarding snakes. He also shared that, to carry out a demonstration session like this, snake species are caught from different places. Once they are

done with the session, the snakes are released back in the area in the area from where they had been brought. The session was remarkable. The students as well as other audience appreciated the session. Their excitement was patent while resource person was demonstrating the snake species. The session ended with vote of thanks given by Mr. Kiran Prakash Naik, Asst. Professor, Dept. of Environmental Studies.

Mr. Rao also responded to all the queries raised by the students followed by some key tips to succeed as a Company Secretary.

The session was followed by a brief interactive introduction to the CA program and ICAI by CA Anup Borkar. CA Udhesh Verenkar made a comprehensive presentation on the course structure and pedagogy of Chartered Accountancy. CA Prasheel Kamat and CA Divya Prabhu added value to the session by providing valuable inputs on how to prepare for CA exams and how to prepare for the challenging practice after getting awarded the CA professional title.

A total number of 35 students from the BBA(FS) programme attended the session. Faculty members from BBA(FS) and B.Com. Department were also present for the session. Students provided a positive feedback for the session appreciating the apt choice of speakers and the clarity in knowledge they obtained during the session. They also requested to conduct similar sessions on CMA and CFA in the next semester.

Guest Lecture on the topic of 'Cash Flow Statement'

The PG Dept. organized a Guest Lecture for the course Managerial Accounting on the topic of 'Cash Flow Statement' for Part I students. The objectives of the session were:

- 1. To acquaint students with the importance of Managerial Accounting in the corporate world.
- To give students an insight into to how financial statements could be misleading w.r.t. the information provided by companies, and how a Cash Flow Statement could help in decoding such information.
- To practically (numerically) help students prepare a Cash Flow Statement as per the New Accounting Standards.

The Resource Person for the Lecture was Mr. Sameer Shaikh, Co-Partner with E-Trenz, Fatorda and a Full time Doctoral

Scholar at BITS-Pilani, K.K.Birla Campus, Goa. 16 students attended the session. Ms. Reneta Costa welcomed the Resource person and introduced him to the audience.



Mr. Shaikh began by interacting with students by putting forth questions to them such as, How do we analyze a Company's Financial position? What are the tools, techniques etc.?He elaborated upon how Managerial Accounting helps Companies make strategic decisions. Mr. Shaikh then gave students an overview as to what was the need for a Cash Flow Statement and how just looking at a Trading & Profit & Loss Account along with a Balance Sheet could be misleading, as they do not reflect the true and fair picture of the Company's Financial Position. He demonstrated through real life cases as to how the Balance Sheet and Profit and Loss Accounts could be manipulated to mislead the investors and general public.

He explained how a Cash Flow Statement used to be prepared earlier and the changes made to incorporate the International Financial Reporting Standards and the International Accounting Standards requirements. He briefly explained the legal requirements for companies to furnish a Cash Flow Statement along with Unaudited and Audited Financial statements of Companies. He elaborated upon the various aspects of a Cash Flow Statement and listed the various components of the Cash Flow Statement – he gave specific instances of what forms part of the Cash Flow Statement and what does not form part of this Statement. Later Mr. Shaikh explained to students the adjustments in a Cash Flow Statement and how to solve a Cash Flow Statement Numerical.

Towards the end of his session, he gave students examination tips to score better for the exams. The session concluded at 1:00 p.m. with Ms. Anisabanu Shaikh proposing the Vote of Thanks.

Session on "Pursuing a Career in Marketing"

The Career and Placement Cell organized a session on "Pursuing a Career in Marketing" on August 26th. The guest faculty for the Programme was Mr. Pavan Agni, Proprietor at Buy Spex Marketing. The main motive of the talk was to make students aware about the various career opportunities in marketing. Mr. Ashwath Majalikar began the session by pointing out the most important differences between banks and Non-Banking Finance Companies, viz. NBFCs cannot accept demand deposits, they do not form part of the

> payment and settlement system, they cannot issue cheques drawn on themselves and the Deposit insurance facility of Deposit Insurance and Credit Guarantee Corporation is not available to depositors of NBFCs.

Mr. Majalikar gave an overview about gold loans and the ease of taking a gold loan. The basic features of gold loans are easy and fast processing - it takes an average of 15 minutes to process a gold loan at Muthoot Finance, not much

documentation needed and they are secured loans.

In order to approve a gold loan, the gold has to be first tested. The tests performed are acid and salt test, sound test and smell test

The session ended with the vote of thanks by Ms. Renia Dias, student of M.Com Part I.

Lecture Series VIII – Company formation procedures & raising of capital 27th August 2019

As part of its regular activity - "TOWARDS BRIDGING THE GAP BETWEEN ACADEMIA & INDUSTRY" – the Department of Commerce organized a session by CA Vikas Singh for students of FY B.Com. 72 students attended.

The objectives of the session were

- 2. To bridge the gap between industry expectations and classroom learning w.r.t. International Marketing.
- 3. To brief students as to how simple concepts learned well, could help them design and develop international projects.

The Guest Lecture on the topic of 'International Marketing' commenced at 11:00 a.m. in the M.Com Classroom. The Resource Person was introduced to the audience by Ms. Priya Pai Vaidya.

Ms. Almeida initially started by interacting with the students and inquiring about their future goals and ambitions. She gave them examples of Goan Brands started by Goans that have crossed boundaries and are very successful in international markets such as Costa Foods, Goan Foods, Vinicola, etc. She motivated students to take up what they are most passionate about and create jobs rather than just being job seekers. She asked

students to think as to how their hobbies could be exploited to become a potential international brand.

She then introduced them to the concept of International Marketing and explained how it is different from traditional sales and marketing in India. She explained the importance of International Marketing in today's world and how there are different ways in which a small business could scale up and enter international markets. She also told students about how suspicious International Markets are with reference to Indian products and services and why none of the Indian Brands are having a dominant market share and position. She also gave real life examples as to how Indians are culturally diverse



compared to their international counterparts in areas relating to Work cultures, Discipline, Stereotypes, Quality Issues and Hygiene etc. to name a few and how these affect Indian Companies in the international arena. She briefed students with reference to the Global expectations from India and how we fail to meet these expectations. Later she also asked students to learn new concepts like Digital Marketing, Web Designing, Analytics etc. so that they could be International Marketers and earn and work in India itself. These courses could also help them scale globally and take up small assignments and projects for International companies. As Ms. Almeida was concluding her session she asked students to dream big, think big and work towards it. She asked them to follow the mantra 'Think globally and Act locally'. The session concluded at 1:00 p.m. with Ms. Anisha Cardozo proposing the Vote of Thanks. The session was very interactive and informative as students clarified their doubts.

Session on 'Initiatives by SHGs through NABARD'

27th August 2019

The Department of Economics & Banking in collaboration with NABARD organized an Informative session for students and entrepreneurs from the public on the topic '*Initiatives by SHGs through NABARD*' on 27th August 2019 from 10:30 a.m. to 12:30 p.m. in classroom no. 203. The objective of the session was to bring about awareness among students and the general public on how to form a SHG and the initiatives offered by NABARD to SHGs. The resource person for the session was Mr. Sushil L. Naik – District Development Manager, NABARD, Goa.

NABARD through long term refinance has disbursed to banks in Goa an aggregate of Rs.65.83 Crore in 2018-19. As on March 31, 2019, it has cumulatively sanctioned 201 projects in the field of agriculture, rural connectivity and social sectors involving a financial assistance of Rs.1867 Crore to the Government of Goa. Against this, the assistance disbursed is Rs.1205 crore. Under NIDA (NABARD Infrastructure Development



Assistance), NABARD has sanctioned 02 projects – Construction of 3rdMandovi Bridge and Porvorim Sewerage Scheme. The total loan assistance sanctioned is Rs.533.29 crore. Besides this NABARD also promotes farm sector initiatives through the constitution of Regional Advisory Group (RAG), it is the Nodal Agency for Government of India schemes and provides awareness and training programmes for farmers as well. Development in the off-farm sector includes sponsoring of stalls in exhibitions for Self Help Groups (SHGs), support to conduct of SHGs

Lokotsav, Bazars, etc., and conduct of training and capacity building programmes for SHGs in Goa. NABARD has provided grant of Rs.16.26 lakh to Goa State Cooperative Banks for issuing RuPay KCCs and micro ATMs in Goa. NABARD has implemented a project of digitization of SHGs (EShakti), introduced schemes for promotion of women SHGs, as well as supported various marketing initiatives of SHGs.

The session commenced at 10:30 a.m. with the welcome address delivered by Ms. Lizette D'Costa, Assistant Professor in Economics and Coordinator of the session, who gave a brief introduction of National Bank for Agriculture and Rural Development (NABARD) being India's Apex Development Financial Institution, formed by an Act of Parliament in 1982 with a mandate of bringing rural development through credit and non-credit initiatives. NABARD being wholly owned by Government of India has its regional offices in all the state capitals of India, District Development Manager (DDM) offices across length and breadth of the country. In Goa, the regional office of NABARD is located at Panaji whle the DDM Office is located in Margao, South Goa District. As a welcome gesture, Vice Principal, Dr. Rodney D'Silva presented the resource person with a potted plant, which was followed by the Welcome address by the Head of the Department of Economics & Banking, Dr. Lira M. Gama, on the importance and need of such a session.

The resource person, Mr. Sushil Naik, very skillfully introduced the topic of SHGs to the audience. He initially informed them about NABARD in Goa and its various functions and its role, which is financial, developmental and supervisory in nature. He subsequently went on to explain how to form a Self Help Group (SHG), the basic requirements and eligibility, SHG linkage with nationalized banks and the way NABARD assists in starting of SHGs. He enlightened the audience on SHG – Panchasutras i.e. Regular Savings, Internal lending, Regular Payments, Maintenance of Books of Accounts and Regular Meetings as the core requirements of the functioning of a SHG. He informed the gathering on the different types of purposes of loans, possible loan amount that can be granted, SHG credit linkage, the concessional rates of interest offered to SHGs, documents, collateral, SHG grading, Rural Mart Scheme – the expenditures at block and district levels. He also spoke about different programmes under SHGs providing the various trainings and initiatives especially for women like seashell craft, bamboo work, cookery and catering, jute and cloth-bag manufacturing, pickle and masala making, etc., and assistance in putting up stalls for Lokotsavs and bazaars. He mentioned that there are presently more than 6000 SHGs operating in Goa and over 100 lakh all over India. The SHG deposits amounts to 17 Crore in Goa and 23000 Crore in India. Further the SHG outstanding loans account for 45 Crore in Goa and 87000 Crore

in the whole of India. The NPAs in SHG lending in Goa is only 4% while all over India is only 7% which speaks a lot about the successful repayments in SHGs. He finally spoke on NABARD's Project of Digitization of SHGs (EShakti) which is being implemented in Goa.

The students and public present were very interactive as many of them posed questions to the resource person, Mr. Naik, who answered them very proficiently during the session.

On the whole, the session was informative and enriching to the audience.

The session ended at 12:00 p.m. with the vote of thanks delivered by Ms. Lizette D'Costa and a memento being presented to Mr. Sushil L. Naik, as a sign of gratitude for delivering the session.

Guest Lecture on "Vedic Mathematics- High Speed Maths"

Ms. Mamta Kumari, Asst. Professor, Department of Mathematics organised a Guest Lecture for the students of FY B.Com on August 27th, 2019 on the topic "Vedic Mathematics- High Speed Maths". The Resource Person was Mr. Sagar Ram Sakordekar – founder of SRS Vedic Mathematics Academy at Mangeshi-Ponda. Mr. Sakordekar is a Chartered Engineer by profession. Mr. Sakordekar has been a member of various boards and

committees. He is also associated with Lions Club and has won many prestigious awards. During the last 13 years, he has conducted a number of workshops on Vedic Mathematics for students at different levels – from high school to post graduation - and also for teachers in Goa, Karnataka, Maharashtra and Gujarat. So, far he has taught Vedic Mathematics to more than 36000 students and teachers.

Mr. Sakordekar gave a brief history of Vedic Mathematics and told students about the Indian Monk Swami Bharati Krishna Tirtha who wrote the first book on Vedic Mathematics, which was published in 1965. He

explained various high speed techniques for doing calculations such as multiplication, division, finding squares and so on. 135 students attended the session. They solved a number of problems using these techniques and enjoyed the session.

Guest Lecture on "Practical aspects of different heads of Income and their chargeability under Income Tax"

The PG Dept. of Commerce organized a guest lecture for students of M.Com Part II on August 27, 2019. The Resource Person was Ms. Shaheena Isani, Tax Consultant, Kulkarni & Bhat.

The main objective of the Guest Lecture was to familiarize students with the practical aspects of different heads of Income and their chargeability under Income Tax. 26 students attended.

Ms. Isani began the session by briefing students about the meaning of Income and tax incidence of different tax payers. She explained the procedure which is followed while filing returns:

- 1. Determination of Residential status
- 2. Classification of income under different heads
- 3. Exclusions of income not chargeable to tax

- 4. Computation of income under different heads
- 5. Clubbing of income of spouse, minor child etc
- 6. Set-off and carry forward of losses
- 7. Computation of Gross Total Income
- 8. Deductions from Gross Total Income
- 9. Total income
- 10. Application of the rates of tax on the total income
- 11. Surcharge
- 12. Education and secondary and higher education cess
- 13. Advance tax and tax deducted at source

The faculty covered different heads of Income with conditions, deductions under different sub sections and exemptions to solve the practical problems.

Different heads of Income covered were: Income from Salary, Income from House Property, Income from Profit/gain from business or Profession, Income from Capital Gain and Income from Other Sources

Under salary head different components were explained which included gratuity and pension; under Income from house property treatment for income received from letting outhouses and self-occupied house was shown; Capital Gain - calculation about the valuation of property as on the date of sale was shown and under Income from Other Sources income from Gift received was explained. Ms. Isani also showed the practical calculation and procedure for filing of returns by using the actual information of anassessee (personal information of the assessee was kept confidential).

In conclusion, she explained the changes made in the current budget with respect to Income Tax, which will be implemented from the financial year 2020-2021.

The session ended with the vote of thanks by Ms. Melita De Souza, student of M.Com Part-II.

A guest lecture was organised by Ms. Ruchira Naik (Asst. Prof in Business Law) for students of SY B.Com on 28th August 2019 on the topic "Consumer Grievance Redressal Machinery & Consumer Rights".

Adv. Jagdish Prabhudesai was invited as the guest speaker. He is the former President, South Goa District Consumer Forum at Margao Goa. He is also a visiting professor for LL.M. at Goa University and other Universities. He is also a practising advocate at the High Court and is connected with various educational and

The session started with a brief introduction of the guest. The guest speaker spoke elaborately on various aspects related to a consumer, he explained the basic concepts, the evolution of Consumer Protection Act 1986, scenario of consumer courts in different states in India, how consumers can be exploited. He stressed on what are consumers' rights and how consumers can enforce these rights by approaching different consumer courts

with different pecuniary jurisdictions.


College Campus, enhance it with an Image Editing Software and add a Caption for the Edited Image.
